BBPD units responded to Dunkin Donuts, 1394 W. Boynton Beach Blvd, Palm Beach County, FL in reference to a report of an ATTEMPTED SEXUAL BATTERY/SIMPLE BATTERY with a 5-minute delay. As units converged upon the area, contact was made with VICTIM and WITNESS/911 CALLER. VICTIM advised, while travelling on foot within the parking lot of BJ's Coin Laundry, 1404 W. Boynton Beach Blvd, an unknown B/M subject, described as 5'02/140#, in his 20's, last seen wearing a grey long sleeved shirt, dark pants, two silver chain necklaces, a black beanie cap and one white sneaker attempted to engaged the victim in a conversation, expressing his desire to go home with the victim. The victim proceeded to walk away from the subject, who responded by approaching the victim, grabbing her hips from behind with his hands, then pulled her shorts down approximately 4 inches exposing her underwear. The perpetrator then proceeded to rub the front of his body several times in a rhythmic motion against VICTIM's back and buttocks. VICTIM reported the perpetrator attempted to remove his penis from his pants and could feel him rubbing himself against her buttocks while making moaning sounds. VICTIM then utilized her rolling backpack to deliver a strike to the perpetrator's bare foot which was successful in thwarting further attack. VICTIM immediately fled towards Dunkin Donuts where she was able to summon assistance from WITNESS/911 CALLER. The perpetrator then fled the area, eluding immediate apprehension.

At approximately 0902 hours, while conducting a follow-up investigation at Dunkin Donuts, Det. Gorfido observed a subject matching the aforementioned description. The subject was immediately detained pending the administration of a photo line-up to VICTIM. At approximately 0925 hours a photo line-up was administered to VICTIM who made a POSITIVE identification. The perpetrator was identified via FL DL as DEFENDANT JESSE LEE ROBERTS IV.

Based on the above facts resulting from this investigation, your Affiant finds probable cause to charge DEFENDANT JESSE LEE ROBERTS IV with 1F count ATTEMPTED SEXUAL BATTERY contrary to F.S.S. 777.04(1)/794.01(4)(b) and 1M count SIMPLE BATTERY contrary to F.S.S. 784.03(1)(a)(1)(b).
