


Officers responded to 2305 N. Congress Ave. #36 (Boynton Landings), Boynton Beach, Florida in reference to a shooting complaint. BBPD dispatch received two 911 calls in which the callers stated that two black males were fighting and then they heard approximately one or two gunshots. Upon arrival, officers located a victim on the staircase suffering from a gunshot wound to his right leg. While officers provided aid to the victim, contact was made with Felix Exilus, who initially stated that he did not know the victim, but heard a gunshot and came outside where he located the victim. Exilus advised that the victim then walked upstairs and was in front of 2305 N Congress Avenue #36 when Exilus came out of the apartment. Officers noticed Exilus had a cut on his left foot that was bleeding. The victim was transported to the Delray Medical Center as a trauma patient.

Officers located blood on the third floor of 2305 N Congress Avenue in between apartment 35 and 36. Through investigation it was determined that Exilus was staying with his girlfriend (herein referred to as Witness 1) in apartment #36. Officers made contact with a second witness, herein referred to as Witness 2, and it was discovered that the victim was dropped off at 2305 N. Congress Ave. #36, in order for the victim to meet with Exilus. Witness 2 then observed Exilus and the victim get into a physical altercation. Exilus was then transported to the BBPD for further questioning. Investigation revealed that after the shooting Exilus went into his girlfriend's apartment and came back outside when officers arrived on scene. Witness 1 then signed a consent to search document for her apartment (#36). Once inside of the apartment, in the kitchen, a black handgun, holster, magazine, and 4 rounds were located sitting in a tupperware bowl with approximately one inch of bleach. Witness 1 directed officers to a pair of yellow shorts in the washing machine which Exilus removed after the altercation because they had blood on them.

Detective Whitefield and I interviewed Exilus at the BBPD. In a taped statement, post Miranda warnings, Exilus stated that he had nothing to do with the shooting, however the victim is a longtime neighbor of his. Exilus stated that he heard the victim arguing with someone that resides on the first floor and he did not come outside until after the victim was shot.


Detective Whitefield and I then conducted a taped statement with Witness 1 at the BBPD. In a sworn taped statement, Witness 1 stated that she observed the victim and Exilus in a physical altercation in the staircase which leads from the second floor to the third floor. Witness 1 then walked back into her apartment after which she heard a gunshot. Exilus then knocked on her door and she let him in. Exilus was carrying a firearm and admitted to witness 1 that he shot the victim. Witness 1 last observed Exilus enter the kitchen area with the firearm (within the same area where the firearm was located by officers).

Detective Whitefield and I then responded Delray Medical Center to interview the victim. The victim stated that he was at the apartment to meet with Exilus, who he has known for 14 years to sell him "percs" which is a known to be percocet pills. The two then got into a physical altercation. Exilus then took out a firearm and shot him in the leg.

Exilus was detained at the BBPD and a search incident to arrest, in Exilus' shorts pocket, a plastic bag was located with an off-white rock like substance which, through my training and experience, is known to be crack cocaine (0.3 grams which was field tested with SIRCHIE NARK wipe). A criminal history check revealed that Exilus was convicted of a felony in 07/15/2015.

Due to the above investigation Exilus was arrested and charged with attempted second degree murder with a firearm, pursuant to F.S.S 782.04(2), felon in possession of a firearm or ammunition pursuant to F.S.S 790.23(1)(A), and possession of cocaine, pursuant to 893.13(6)(A).
