



As of January 2021, the Boynton Beach Police Department has received several reports and complaints from female citizens that the massage therapists at Bao Foot Spa located at 1313 W. Boynton Beach Blvd are inappropriately touching the clients in a sexual manner. On more than one occasion, a victim reported being touched on the vagina by a massage therapist named "Juan". On August 5th, 2021, BBPD again received a call from a victim who will be referred to as hereon, advising she was inappropriately touched and penetrated by the massage therapist at Bao Foot Spa. BBPD road patrol made contact with who further advised when she was at the business today around 1300 hours, she received a thirty-minute massage by an Asian male who was approximately 5'4", 130 lbs with brown eyes and brown hair. stated during her massage, she was lying on her stomach without a shirt and only workout "yoga type" pants on that were rolled down to below her hips as instructed and staged by the therapist. then stated as the therapist started her massage on her neck and back, he began to slowly start moving his hands forward each time to touch the side of her breast to at one point almost touching her nipples stated in order to prevent him from touching her any longer on her breast, she put her arms down to her side to block his hands. Once, locked the therapist from touching her breast any longer, he then moved down to her lower back and hip area to begin massaging. While the therapist was massaging that area he then began to start moving his hands forward more and more each time towards her groin area. stated after a few minutes she then felt the therapist move his hands all the way forward to her vagina and then insert two fingers inside her. Once the therapist did that, immediately told him "no" which in return the therapist stated something along the lines of "you don't like and just tell me what you want". At that point, stated she was so shocked and scared she just continued to ask the therapist if her massage is over but the therapist continued to massage her until she was able to finally sit up, get dressed and walk outside of the massage room advised when she walked out to the lobby of the business, she quickly paid for the service and left without leaving a tip. Finally, advised when she arrived home, she decided to report the incident to PD but she first called to get the name of her therapist which she was able to find out his name was "Juan".

Based on the above, BBPD and responded back to Bao Foot Spa to make contact with the manager and "Juan". Initially when officers and detectives asked the manager to go get "Juan" she denied the victim being at the business on that date and "Juan" working. However, soon after the manager went to the back of the business to retrieve "Juan" who already tried to walk out the back door of the business but quickly walked back inside when he noticed the presence of officers behind the business. As "Juan" walked to the front of the business, immediately identified "Juan" as her massage therapist that day and the male who penetrated her vagina with his fingers without consent. "Juan" was soon after identified as Qui Vanh Voong, arrested and TOT BBPD.

At BBPD, Voong agreed to speak with detective post Miranda. Voong admitted to giving a thirty-minute massage on this date to a female and also being the only male at the business who goes by the name "Juan". Voong however denied ever touching a client's vagina because he only gives precise, professional massages. Voong was ultimately TOT PBCJ. Given the above, I find probable cause to charge Voong with one count of sexual battery as Voong, a person eighteen years of age or older, did commit sexual battery upon a person 18 years of age or older, without consent, by vaginal digital penetration and in the process thereof did not use physical force and violence likely to cause serious personal injury, contrary to Florida Statute 794.011(5)(b).
