Officers responded to 480 W Boynton Beach Blvd in reference to a shooting. Upon arrival, officers made contact with 3 victims and who were parked in their vehicle. The driver of the vehicle, said that she had just left her house in her vehicle, along with her sister who was seated in the passenger seat, and her brother in law who was seated on the drivers side of the back seat. said that as she was traveling westbound, approaching the 200 block of West Boynton Beach Blvd, she observed two B/M's crossing the street from South to North. said that she slowed her vehicle and almost had to come to a complete stop so that she would not hit the two subjects. informed officers that her sister, in frustration of the subjects crossing the street in traffic, threw her hands in the air. advised that one of the subjects in response to her sister making the gesture, pulled a gun from his waistband area and began shooting at the vehicle. advised that she turned her wheels away from the subjects and slammed on the gas to get out of the area. Her brother-in-law called 911 and she pulled her car into 480 W Boynton Beach Blvd. to meet the responding officers. Officers inspected the victim vehicle which had been struck 5 times by bullets, three of which went through the rear passenger side door. BBPD Crime Scene responded to the scene and collected several 9mm shell casings.

Because the victims were driving by and everything happened in a matter of a few seconds, some of the details of the suspect descriptions were off. Both described the shooter as a slim B/M in his late 20's wearing a purple shirt and jeans. They both advised that the shooter had dread lock style hair, approximately ear length and advised that the root area of the hair was a lighter brown than the rest of the hair. also informed me that the subject appeared to be coming from a gas station on the South side of the road that they were crossing because he was carrying a bottle of beer in a paper bag.

On 10/11/21, video surveillance footage from the gas station was retrieved. At approximately 1:14 PM, two subjects are captured entering the store, one of whom is wearing jeans, a purple shirt, has dread lock style hair approximately ear length and lightly browned around the roots. I immediately recognized the suspect to be James Frederick, with whom I have personally dealt with in the past and was currently investigating in reference to him being a suspect in a Lantana PD shooting case less than two weeks prior.

In the video surveillance, Frederick is seen exiting the store at 1:17 PM with two beer bottles, one of which he puts into a brown bag. Frederick is seen crossing the street at 1:18 PM and as he exits out of camera view for just a few seconds, people in front of the gas station are seen ducking and the victim vehicle is seen driving by. The video then shows a suspect begin running northbound down NE 2nd St from the area where Frederick was last seen in the video.

On 10/12/21, contact is made with Frederick's great grandmother, Louise Denson. Denson was shown a still shot picture of Frederick in the store and asked, "Do you know who that is?" Denson replied, "that's James" and "he's my great grandson".

Contact was made with all three victims on 10/12/21. Due to the fact that Detectives were unable to obtain a recent picture of Frederick, a picture from over 5 years ago was used and the victim's were unable to identify Frederick. The victims were shown a screen shot of Frederick in the store prior to the shooting and all three confirmed that with 100% certainty that was the person who shot at them.

On 10/13/21, contact was made with another witness who did not see the actual shooting; however, heard the shots and immediately looked to see what was happening. The witness confirmed that she saw a B/M with dread lock style hair and wearing a purple shirt running northbound on NW 2nd St.



On 10/13/21, Frederick was arrested in West Palm Beach for another shooting. An updated booking photo of Frederick was obtained and placed into a photo lineup for victim. Frederick was positively identified as the person who shot at her vehicle.

On 10/13/21 contact was made with Frederick at the Palm Beach County Jail. It was discovered that Frederick had cut his dread locks from his head; however, the roots remained a brownish color. When informed of his charges Frederick questioned as to why he was being charged for the shooting. I informed of the surveillance cameras that captured him at the store and crossing the street when the shooting occurred. Frederick said that he was aware that the actual shooting was not captured on the surveillance footage because he went to the store himself and made the clerk show him the footage.

It was discovered that James Frederick is an 11 time convicted Felon. Most recently Frederick was convicted of F

Based on the above mentioned facts, probable cause has been established to charge James Frederick with 3 counts of Attempted Second Degree Murder, 1 count of Felon in Possession of a Firearm and 1 count of Discharging a Firearm in Public.
