On 10/30/21, 0900 hours, arrived at the police station as scheduled and I spoke with her in an interview room with Officer Gomez ID#1119 present (interview captured on Officer Gomez's BWC and preserved as evidence). Prior to the interview, Officer Gomez read her Miranda rights. ated she understood her rights and she signed the rights card (signed card placed into evidence). The following is a brief synopsis of tatement; refer to BWC footage for interview in entirety. stated she is unemployed but attends college on-line and is studying "pre-med" with the intent of becoming a doctor. stated she and her boyfriend own a total of seventeen (17) dogs of various breeds, including "Snow". stated they breed the												
dogs and sell puppies. Idmitted neither she nor her boyfriend possess a Hobby Breeder permit (as required by local ordinance) and she also admitted they do not provide veterinary health certificates when they sell dogs/puppies (as required by state statute). Stated she and her boyfriend acquired "Snow" approximately four months ago from a breeder in north Florida. Stated the dog has never been seen by a veterinarian while in her and her boyfriend's possession. Stated that at some point, "Snow" developed an unknown medical condition on her paws so her boyfriend took the dog to another breeder for medical advice. Stated she and her boyfriend self-treated the paws and did not seek professional veterinary care. Stated that approximately two weeks ago, she woke up one morning and the dog's right forepaw "was gone". Stated she treated the dog with penicillin she had left over from another dog's c-section surgery and placed a bandage over its ieg. Stated she changes the bandage daily and she believes the dog has greatly improved. Eadily admitted she is aware of the fact the dog's bone is protruding from its leg and she readily admitted she chose not to seek veterinary treatment.												
stated she recently had an outbreak of the parvo virus at her home so she took all of her and her boyfriend's dog/puppies, with the exception of "Snow", to Best Vet Animal Hospital for treatment and safe-keeping while she was in the process of cleaning
