I received a CyberTip (#97342754) from the National Center for Missing and Exploited Children (NCMEC) in which alleged child pornography was uploaded online via the application Snapchat. A review of the uploaded video showed an unknown white male child (8-10 y.o) involved in solo sex acts (masturbating) which was uploaded to Snapchat on 08/04/2021. Via Comcast subpoena the upload of the video of the child was found to have taken place 4480 Lady Beverlee CT S Boynton Beach FL 33436 (PBC). BBPD investigations also identified the suspect behind the upload as Chase Walker 09/24/1999.

On 11/04/2021 with the assistance of Sarasota PD contact with Chase was made in Sarasota where he was working as an acting apprentice with the Children's Theater. Chase provided a statement to SPD where he confirmed that he did not have Snapchat anymore following being kicked off because of the CyberTip incident. Chase confirmed the sharing of nude photos back and forth online and provided that he fantasizes about young children in a sexual manner. Chase confirmed that he has had child pornography of his phone before, but he has deleted it all. Chase provided that he gets his child pornography from Twitter and he sometimes puts in, 14 year olds, for the search believing that to be his preference. When asked how many boys he has talked to on Snapchat, Chase provided he did not know the number. When shown a sanitized photo of the child from the uploaded video from the CyberTip, Chase provided that he believes that is the child he was talking to online. When asked directly if he fantasized about this young boy Chase said, Yes. During the interview the child in the sanitized photo was provided an age of 9-10 years old and Chase stated that he met the child online on Omegle.

It is unlawful for any person to knowingly possess, control, or intentionally view a photograph, motion picture, exhibition, show, representation, image, data, computer depiction, or other presentation which, in whole or in part, he or she knows to include any sexual conduct by a child. Due to the totality of events I am filing for a warrant for the arrest of Chase Walker 09/24/1999 in reference the Viewing of Child Pornography
