



<p>On December 10th, 2021 at approximately 1241 hours, BBPD Officer Gomez responded to Ulta Beauty located at 363 N Congress Ave in Boynton Beach, in reference to a theft.</p> <p>Upon arrival, a sworn statement was taken from the store manager, Donna Heckman, who stated that a black male, later identified as Lamar Allen (DOB 01/25/1988), came into the store and stole \$1,436.00 worth of cologne the prior evening, December 9, 2021 at 2039 hours. Heckman advised that store employees witnessed Allen, who was described as a black male, wearing a black shirt with red letters that read "REAL", black pants, and Champion brand slide sandals. Allen entered the business and walked straight to the fragrance section where he quickly selected several high-end colognes (Dior, Dolce and Gabbana, YSL, and Marc Jacobs) and placed them into a large paper Marshalls shopping bag. Moments later Allen walked out of the business passing all points of sale and made no attempt to render payment for the merchandise. The incident was captured via store surveillance.</p> <p>Upon review of the video, I requested our crime analyst create and disseminate a BOLO to identify the subject. At that time, the analyst recognized the subject in the video as Lamar Allen, who she had observed in previous other theft BOLOs from other jurisdictions. She proceeded to provide his Facebook account, Lamar Allen (The Black Widow) and he is pictured in photographs with the same clothing, large gold pendant, stud earrings, and facial hair and features. It was also learned that Allen had recently been arrested for a grand theft by PBSD Detective Shackelford ID #28282 (case # 21115800). Still photographs from the video surveillance at Ulta Beauty were shown to Det. Shackelford and he identified the subject as Lamar Allen. Additionally, Allen was identified by Officer C. Rivera, who has worked the area of Boynton Beach that Allen has frequented and resided in for over ten years during which time she has had multiple encounters with him.</p> <p>Based on the aforementioned, I find probable cause to charge Allen with one count of Grand Theft in violation of F.S.S. 812.014(2)(c)(1).</p>
