Boynton Beach Police Officers responded to the BBPD lobby, making contact with 14 year old VICTIM and her mother in reference sexually explicit content being sent to 14 year old's phone. The VICTIM provided a sworn statement where she advised the prior evening the JV cheerleading coach at her school, later identified as Cassidy Sottolare, friend requested her via Instagram. Victim advised that she accepted the friend request and Sottolare then wrote her about wanting to spoil and fuck with her. Victim advised that Sottolare confirmed knowing her age to be 14 years old with Sottolare providing her age as 27 years old. Victim/mother then provided BBPD with consent/access to Victim's cell phone and Instagram account. A digital extraction from the VICTIM's phone provided Instagram direct messages reflective of the statement given by the VICTIM.

BBPD Detectives then took control of the VICTIM's Instagram account making contact with Sottolare possessing as the VICTIM. Direct messaging through Instagram with Sottolare then directed their conversation to cell phone text messaging where the VICTIM was again identified as 14 years old. Sottolare texted about sex experience with the VICTIM and smoking with the VICTIM. Sottolare made statements via text like she knows what girls like, how they like it and where the rights spots are. Sottolare provided that she wanted the VICTIM to sit on her lap and give her a kiss providing that the VICTIM's clothes did not have to stay on. Via text message Sottolare repeatedly kept attempting to have the VICTIM meet with her.

BBPD, still possessing as the 14 year old, eventually advised Sottolare that the VICTIM was sneaking out the house where Sottolare provided that she would come to the VICTIM's location. BBPD Officers then made contact with Sottolare at the 3400 blk of High Ridge Rd in Boynton Beach where she had been directed to that location as where the VICTIM would meet her. Upon contact Sottolare was alone driving a 2018 blue in color Toyota FL #234QLP and officers observed a cell phone her possession which showed the geo-location provided for the VICTIM and the last number of texts.

Due to the totality of events Cassidy Sottolare was placed under arrest for Offense Against Student by an Authority Figure, Traveling to Meet a Minor and Driving While License Suspended Habitual.

Post Miranda warnings Sottolare then provided that she had a romantic connection to the VICTIM, knew the VICTIM's age to be 14 years old, found the VICTIM Online, admitted to the texting with the VICTIM and admitted to coming to pick the VICTIM up.
