<p>On April 1, 2022 at 1159 hours, BBPD units responded to the area of 504 NE 12th Ave in reference to a call of shots fired. Upon arrival, officers located several people on scene who stated that they heard gun shots, however no cooperative witnesses were identified and no additional information was gleaned. The area was canvassed for shell casings and damaged property, however nothing was located. The shooting was in broad daylight and several people were in the area including a young toddler inside the store where the shooting occurred (Cherry Hill Mini Market, 1213 NW 4th St).</p> <p>Video was obtained from Cherry Hill Mini Market and it was discovered that the shooting was captured clearly. At 1156 hours (1056 time stamp due to video being an hour off), three minutes prior to the 911 call, a black male, later identified as Tavonte Clemons (DOB 03/28/1986), could be seen on the north side of the building shooting northbound through an open field towards NW 13th Ave. Clemons was observed raising a black Glock handgun with an extended magazine with his right hand before gripping the firearm with both hands. Clemons then took a squared off stance and fired seven rounds towards an unknown black male subject in the field. The apparent target of the shooting could not be seen clearly enough to be identified. After the shooting, Clemons lowered the handgun in his right hand and quickly walked while crouching down and looking behind him, to the front of the store which faces east. He then entered Cherry Hill Mini Market and, as he crossed the threshold, he placed the handgun in his right pocket. Inside the store, a male asked him who he was shooting at to which he stated, "Paul". Clemons then exited the store and headed southbound on NE 4th St while the male inside the store and b/m Bernard Wright (DOB 09/30/1952) continued conversation mentioning several times that Clemons had shot at a subject known as "Paul".</p> <p>In the video, I immediately recognized Clemons as a victim from a shooting I worked a few weeks prior, March 09, 2022, in front of 512 NW 11th Ave. At that time, Clemons was shot in the leg while wearing the same clothing as the shooting on April 1st; a distinct black shirt with a neon print and a NASA emblem and matching black shorts. Members of the BBPD Violent Crimes Task Force also confirmed the shooter to be Clemons.</p>
