<b>On 8/7/2021</b>		<b>At 1:27:00 AM</b>			

On the above date and time, Boynton Beach Police received a call of shots fired in the area of NW 11th Ave. Upon arrival, officers located Victim 1 in the middle of the roadway suffering from a gunshot wound. While providing treatment for Victim 1, a second victim suffering from multiple gunshot wounds was located approximately 250 feet to the east of Victim 1. Boynton Beach Fire Rescue responded to the scene and began treating both victims. Victim 1 was pronounced dead on-scene, while Victim 2 was transported to Delray Medical Center. A short time later Victim 2 was pronounced dead at Delray Medical Center.

Detectives responded to the scene and began receiving information from a confidential source and family members of the victims. Detectives were informed that people were saying that the shooter was Tony Edwards Jr. A search of the crime scene revealed twenty-four 9mm shell casings and one live 9mm round. The live round, a 9mm F.C. (Federal Cartridge), had a gold colored cartridge case and a red projectile. There were two cell phones located on scene, one of which was found near Victim 1 and the other was found near Victim 2. Both cell phones were collected by Boynton Beach Crime Scene. It was later discovered that the cell phone located near Victim 1 belonged to Tony Edwards Jr. The phone number associated with the phone was confirmed by Edwards Jr.'s mother to be his phone number. Detectives also obtained video surveillance of the incident after securing a search warrant to collect the footage.

Contact was made with family members of Edwards Jr., who confirmed that they heard from people that he was responsible for the shooting. Edwards Jr.'s mother was cooperative with detectives and said that he called her at 4:44 AM on 08/07/21 and told her that he was sorry. Edwards Jr.'s mother said that she told him that he needed to turn himself in, to which he responded "I'm not going to turn myself in right now." It was also discovered that a firearm belonging to a family member was missing from a family member's residence where Edwards would frequent and sometimes stay. The firearm missing was discovered to be a 9mm Luger pistol and it was confirmed that the ammunition that was loaded in the missing firearm was 9mm F.C. with gold colored cartridge's and red colored projectiles, an exact match to the live round found at the crime scene. The remainder of the matching ammunition and the box for the stolen gun were turned in to detectives.

On 08/08/21, detectives met with the families of both victims separately and were informed about Witness 1, who was with the victims when the shootings occurred. On 08/09/21, Witness 1, whose identity is known to law enforcement, met with detectives and provided a sworn taped statement. Witness 1 advised that on the night of 08/06/21, going into the morning of 08/07/21, he was with a group of individuals to include both victims and the suspect, whom he knows only as "Junior." Witness 1 said that they were all hanging out around the Cherry Hill Mini-Market having some drinks, talking and listening to music. Witness 1 said that there were no issues or arguments going on prior to the shooting and it appeared that everyone was just having a good time. Approximately three minutes before the homicide, Witness 1 said that the group moved over to the area where the shooting took place because they were getting ready to leave and that is where their cars were parked. Witness 1 described that Victim 1 played one last song from his vehicle before they called it a night. Witness 1 described that Victim 1 was just dancing in the road, while Victim 2 was standing behind his ATV. Witness 1 advised that "Junior" walked up to the right side of Victim 1, raised a firearm and shot Victim 1 in the right side of the head without warning or reason. He advised that Victim 2 suddenly began to run eastbound after seeing this, at which point "Junior" began shooting at Victim 2 a few times before chasing after him. Witness 1 said that he did not see how Victim 2 was ultimately killed because he began tending to Victim 1.



Witness 1 positively identified Tony Edwards Jr. in a six-person photo array as the person he knew as "Junior" and the person whom he saw shoot Victim 1 in the head. After the lineup identification was complete, Witness 1 was shown video of the incident which showed two subjects running eastbound from the area where Victim 1 was shot. Witness 1 positively identified Victim 2 as one of the people running and "Junior" as the person chasing after him. The video then clearly shows that Victim 2 is shot by the person Witness 1 identified as "Junior," causing him to fall to the ground. Victim 2 is then shot several more times by the person Witness 1 identified as "Junior."

During the investigation it was discovered that Tony Edwards Jr. is an eleven time convicted felon. Edwards was most recently convicted of a felony on 04/29/21.

Based on the above mentioned facts, probable cause has been established to charge Tony Edwards Jr. with two counts of First Degree Murder with a Firearm (premeditated) and Felon in Possession of a Firearm or Ammunition.
