On 04/6/2022, at approximately 0726 hours, officers responded to 4 Points Market and Eatery, 645 W. Boynton Beach Blvd. in reference to an armed robbery. While in route, BBPD Communications advised that an unknown white male stated to the store clerk that he has a gun and to empty the register.

Upon arrival, officers made contact with the clerk who advised in a sworn statement that she had been working the register when an unknown white male approached the counter. The clerk advised that the suspect's demeanor was calm and discreet when he walked up to the counter and told her that he had a gun under his shirt. She advised that the suspect asked for cigarettes and to empty the cash register. The clerk then gave the white male a pack of Marlboro Reds and approximately bills. The male then exited the store with the money and merchandise and left in an unknown direction. The clerk described the suspect to be in his thirties, approximately 5'11" with a medium sized frame.

This incident was also captured on CCTV surveillance video and the suspect is observed standing in line at the store with a Sierra Mist soda bottle in his hand. He is seen waiting in line, shaking and tapping his left leg. When he approaches the register, the clerk gives him a pack of cigarettes then opens the register and hands him cash. The suspect then leaves the store and goes in a westbound direction. The suspect had a face mask, and was observed wearing black hoodie, black pants, black boots. On video you can clearly identify a distinct tattoo on the suspects left hand as he reaches to grab the money. The tattoo appears to be a skull and a birthdate. Also noticeable is a black eye under the suspects left eye.

On 04/07/22, surveillance video still pictures (BOLO) were disseminated throughout the department and the suspect was subsequently identified as Adrian Garland. Further investigation revealed that Garland has the same tattoo on his hand that matched the suspect in the surveillance video at the 4 Points Market and Eatery.




On 04/8/22 at approximately 0027, Garland was detained and transported to the BBPD. Post miranda warnings, Garland denied being involved in the robbery and requested counsel. Garland did have a black eye under his left eye which he stated was from a fight with his girlfriend. Garland showed the distinct skull tattoo on his left hand and stated that the birthdate is his mother's birthday. He was also wearing high top black sneakers which he was pictured wearing during the robbery.

Due to the above investigation, Garland will be charged with Robbery with a firearm, pursuant to F.S.S. 812.13(1)and(2)(a).
